The rights of the individual have been considered in line with the Human Rights Act and it is my assessment that rights of the individual are superceded by the rights of society to have such serious offences fully investigated and assist in the apprehension of associated offenders.

**Necessity**

Despite the arrest of EREN and AMOYAW-GYAMFI, their gang continues to operate. It is believed that these subjects will continue to operate his criminal enterprise from within the prison system, which may include inciting other gang members to commit violence and murder. Without the information requested in this application police will be unable to identify those who are in contact with EREN and AMOYAW-GYAMFI and will be unable to identify any disrupt any further conspiracy to commit serious violent crime. This information is necessary to prevent and detect serious crime, namely firearms offences and/or murder.
