I am employed by Her Majesty's Prison Service and currently based at HMP BELMARSH Prison, THAMESMEAD, LONDON, SE28. I have been working in the prison service for 15 years, and currently work as a supervising officer in the Security Department which has access to prisoner visits data.

Each prisoner, whilst detained by Her Majesty's Prison Service, has the right to receive visitors. Whilst on remand, a prisoner can receive unlimited visits.

A visit is booked contacting the relevant Prison and recorded on an online system, C-NOMIS. This request can be made by fax, email or telephone. A name, address and telephone number is recorded for the date and time of the requested visit. Their relationship to the prisoner is also recorded.

On 19/04/2016, I was asked by Police to provide specific information confirming a social visit made by Ozcan EREN, where he visited prisoner Izzet EREN, prisoner number A0647AQ at HMP WORMWOOD SCRUBS on 23/11/2015.

I have checked the visitor records on the C-NOMIS system for Mr Izzet EREN and can see he was an inmate at HMP WORMWOOD SCRUBS between 29/10/2015 and 11/12/2015 when he moved to HMP BELMARSH. His visitor records follow the prisoner when he moves prisons. During this period, it can be seen he was visited on 23/11/2015 by Elif EREN, Mehmet EREN, and Ozcan EREN.

The following table gives details of that visit on 23/11/2015 whilst he was at HMP WORMWOOD SCRUBS.
