Conspiracy to escape lawful custody.
 Possession of an imitation firearm with intent to commit an indictable offence.

Opening.

This investigation involves the following males Nathan MASON, Gokay SOGUCAKLI, Ozcan EREN, and Eren HASYER who conspired together to facilitate the unlawful escape of Izzet EREN and Erwin AMOYAW-GYAMFI who on Friday 11th December 2015 were in lawful custody in transit to Wood Green Crown Court for sentencing.

Officers from the Serious and Organised Crime command mounted a pro-active operation to thwart this conspiracy. During the armed phase of this operation, co-conspirator Jermaine BAKER was fatally wounded.

In light of this there is a parallel investigation being conducted by the Independent Police Complaints Commission and the Metropolitan Police Directorate of Professional Standards. This has resulted in some delays and a large amount of evidence not being immediately available to the investigation team.

Synopsis.

What follows is a summary of matters leading up to the events of 11th December 2015 and particulars of key evidence gathered.

27th August 2015.

On 27th August 2015 a black Audi A6 VRM [DPA] was stolen from an address in Fulham West London.

This was to be the mission vehicle for the escape attempt of Izzet EREN and Erwin AMOYAW-GYAMFI.

13th October 2015.

On 13th October 2015 Izzet EREN and Erwin AMOYAW-GYAMFI were arrested in possession of a scorpion sub machine gun and a semi automatic handgun. Both males were later charged with possession of a firearm with intent to endanger life.

28th October 2015.

Enquiries have identified that on 28th October 2015 a fishing and airgun supply shop named [DPA] at [DPA] sold a mini Uzi BB gun bearing serial number 41112526. The buyer is recorded as M Ali of [DPA]

29th October 2015.

On 29th October 2015 Izzet EREN and Erwin AMOYAW-GYAMFI were transported from HMP Thameside to Wood Green Crown Court for plea and case management hearing. At court both males pleaded guilty to possession of a firearm with intent to endanger life. Both were then remanded to appear on 11th December 2015. Following the hearing both males were conveyed to HMP Wormwood Scrubs.

4th November 2015.

On Wednesday 4th November 2015 black Audi A6 estate S line displaying the VRM **KM13YPT** was found parked and unattended in Palace Gates Estate, Eastern Road, Bounds Green, N22. The vehicle was parked in the far right end corner of the car park, facing the kerb. The car park has metal gates which are usually closed; it is secluded and not visible to passing traffic. Inside the vehicle in the middle of the rear seats was a silver coloured wheel brace. A check on the vehicle identification number revealed the true VRM [DPA]

23 November 2015.

On 23rd November 2015 Ozcan EREN visited Izzet EREN at HMP Wormwood Scrubs. Ozcan EREN then drove to Golders Green where he stopped for a short period and then to the Haringey area.
