Continuation of Statement of

FE19

I attended a secure police building at about 0430 hours, after starting duty at 3am. My previous day's duties had been 8am until 9pm.

I was then present at a briefing with the Senior Investigating Officer (SIO) & all other personal involved in this days operation. This was given by FE16 with all present introducing themselves. I had previously attended a briefing held at New Scotland Yard, the day before in relation to this operation where an over arching briefing had been provided about the intentions of the days operation by FE16 and the officer in the case.

My role on Friday December 11th 2015 was to act as an intelligence officer, and to update FE16 with intelligence that I received. I also took on the role of liaising and on occasion directing other officers from the OCC, who were acting in a number of roles, from support teams on the ground, monitoring a Covert Monitoring Post (CMP) and assisting with observations and CCTV. During the course of the operation I updated FE16 with several pieces of intelligence that I had received, and I made welfare checks on the staff in the CMP to ensure they had sufficient staff and were not encountering any problems. I made the decision to not start passing information to FE16 that had come from the CMP as it could become confusing for them assessing where I was obtaining the information from. I was aware that FE16 was receiving updates from staff who were working in the CMP

As the operation progressed there was a great deal of activity in the operations room, with numerous radio channels being monitored detailing various aspects of the operation. I was aware that the prison van that contained Mr Eren and Gyamfi had left the prison, and I was also aware that the car believed to be part of the plan to free Mr Eren (KM13YPT) had moved from where it had been stored in Eastern Avenue, and was now close to Wood Green Crown Court. At this stage I was not aware of who was in the vehicle, or its exact location.

As the operation progressed I tasked various officers with monitoring remote observation posts and CCTV feeds. I also deployed officers to locations around the route that the van would take to the Crown Court in an effort to identify others who may be involved in this criminal conspiracy.

I was aware at some point that the TFC (FE16) had made a decision to deploy armed officers to detain the occupants of the black Audi A6 (KM13YPT) and moved the operation to what is known as 'state amber'.

I continued to liaise with support units that were in the area, and then became aware that armed officers had moved in to detain the occupants of the Audi A6. After a few seconds I heard over the radio something similar to, if not exactly "shots fired". I then became aware that somebody had been shot during the operation.

I knew there were a number of officers from the OCC in support of this operation at various parts of London. I directed some to remain searching for others who may be part of the conspiracy and others to try and assist. I then became aware that Ozcan Eren had been seen in a car that appeared to be following the prison van that contained Izzett Eren and Mr Gyamfi. I began to try and direct OCC officers towards that location with a view to stopping the car and detaining the occupants. I then heard that the vehicle that was believed to contain Ozcan Eren had been lost from the sight of the officers. After a few minutes I heard it had been again located and that it had been stopped. Once I was aware that there were sufficient officers at the scene dealing with Ozcan Eren I directed other officers who I
