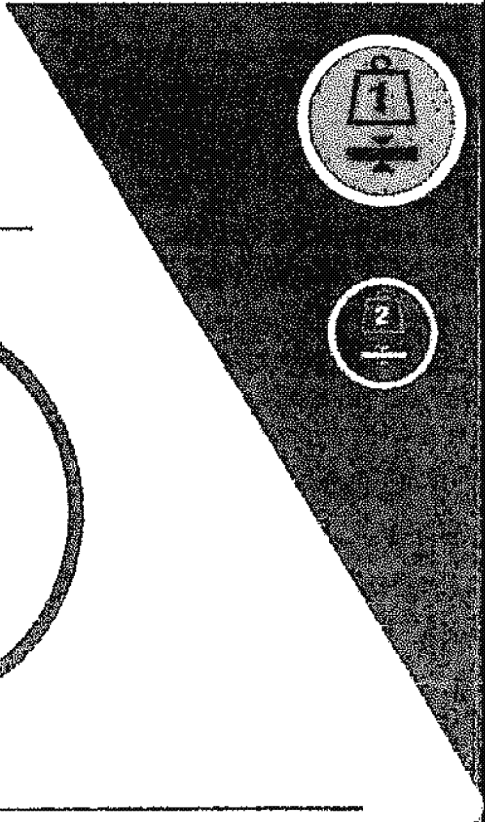

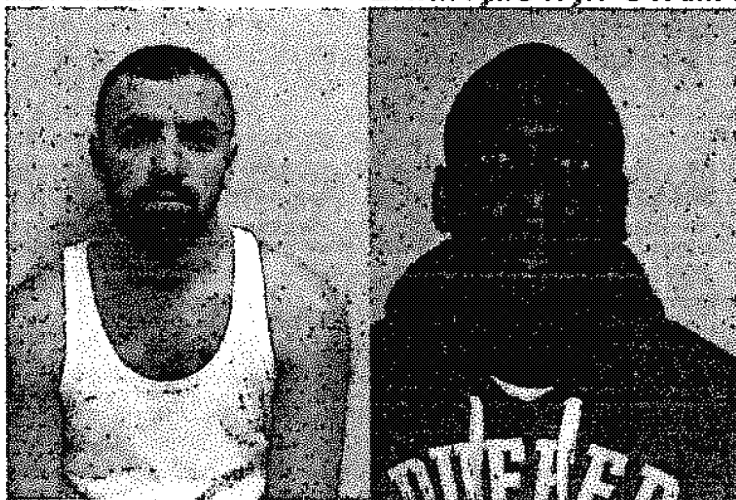
Operation ANKAA targets those who are believed to be involved in facilitating the escape of prisoners from lawful custody.

*BACKGROUND*

On 13/10/2015 Izzet EREN & Erwin AMOYAW-GYAMFI were arrested in possession of a loaded Scorpion sub-machine gun and semi-automatic handgun. They were charged and remanded and pleaded guilty at the first opportunity. They are both currently on remand at HMP Wormwood Scrubs whilst they await sentencing.

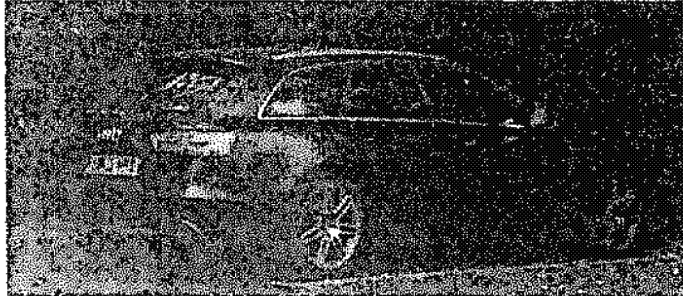

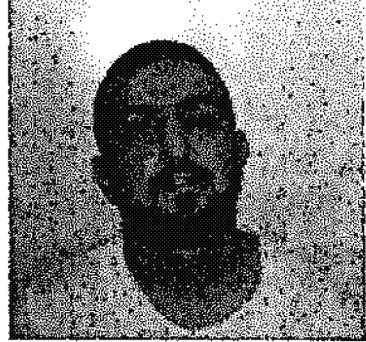

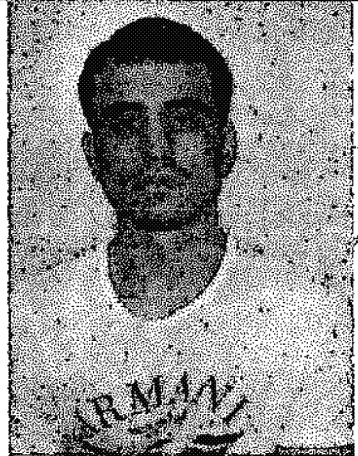
