On Friday 11th December 2015 I was on duty in full uniform driving a marked Armed Response Vehicle call sign TJ584. I was in the company of **D55** (front seat operator) and **G93** (rear seat operator).

At 05.00hrs we attended a tape recorded briefing at ENFIELD PATROL BASE. We were deployed in support of SFO Teams and Armed Surveillance in Operation ANKAA at WOOD GREEN CROWN COURT.

As part of this we were tasked to assist in stopping a BLACK AUDI VRM: **DPA** which was in the BOUNDS GREEN ROAD area.

We made our way from our location and sighted the vehicle travelling towards us on BUCKINGHAM ROAD. I could see two male occupants in the front. I drove passed it and made a U-Turn in order to follow the vehicle. I could see in the distance that it turned left into PARK AVENUE, as we turned it I saw it turn right into BARRETT AVENUE. As we turned in I accelerated towards the vehicle that was already starting to pull over on the nearside. I stopped just short of the vehicle and saw a male who I now know to be Ozcan EREN dob **DPA** getting out of the drivers seat. **D55** deployed from the passenger side and was already engaged in conversation with EREN as I got out and joined them. I handcuffed EREN in a rear stack handcuff position due to the information I had received earlier in the briefing. I said to EREN "You are under arrest for assisting an offender" I cautioned him at 09.23hrs to which he made no reply. I gave him a pat down for any obvious weapons as the intention was to hand him over to an arrest team. During the time I was with him he asked "Have you got the right person? Which offender am I assisting?" I said this will all be explained to you in due cause when an arrest team get here. He looked over to his passenger as said "Are you an offender?" Whilst waiting I asked if his handcuffs were ok and he said one was tight, I readjusted the handcuffs made sure they were ok and double locked them to prevent any discomfort to him. EREN was wearing a Black 'Stone Island' Jacket, faded black jeans, black trainers and a brown jumper. I handed EREN over to an officer from SCD7 who arrested him and replaced my handcuffs. We then left the scene to complete notes.
