On Friday 11th December 2015 I entered cell number 5 in which Gokay SOGUCAKLI was, having been arrested for firearms offences.

I entered along with DC Tom O'Toole and DC Stewart Yeadsley, with the intention of seizing the clothing he was wearing and giving him new clean replacements and also taking firearms residue samples. We entered and we explained what we were going to do and I took the firearms residues samples which I exhibit as MPS/F/111215, and seal with seal number N04687921.

During the course of taking the samples he made an unsolicited comment, "why haven't you tested the gun, you can see its only a pellet gun, that's what they told me when I got in trhe car, you can buy it for £200 in a shop, it's a toy, I was asleep and they shot my mate and opened him up." I told him I was going to leave the cell to write up what he had said to me and would return with it written up where it would be offered for signing. I did this immediately and he approached the wicket and said no he wasn't signing as he was being interviewed. I noted the refusal and time stamped my book at 14.20
